

## **Dustex Privacy Policy**

### **Privacy Policy:**

Dustex ("Dustex") operates dustex.com.au and may operate other websites. It is Dustex's policy to respect your privacy regarding any information we may collect while operating our websites.

### **Website Visitors**

Like most website operators, Dustex collects non-personally identifying information that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Dustex's purpose in collecting non-personally identifying information is to better understand how Dustex visitors use its website. From time to time, Dustex may release non-personally identifying information in the aggregate, for example by publishing a report on trends in the usage of its website.

Dustex also collects potentially personally identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on dustex.com.au blogs/sites. Dustex only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally identifying information as described below, except that commenter IP addresses and email addresses are visible and disclosed to the administrators of the blog/site where the comment was made.

### **Gathering of Personally Identifying Information**

Certain visitors to Dustex's websites choose to interact with Dustex in ways that require Dustex to gather personally identifying information. The amount and type of information that Dustex gathers depends on the nature of the interaction. For example, we ask visitors who sign up at [dustex.com.au](http://dustex.com.au) to provide a user name and email address. Those who engage in transactions with Dustex are asked to provide additional information, including the personal and financial information required to process those transactions. In each case, Dustex collects such information only as necessary or appropriate to fulfill the purpose of the visitor's interaction with the company. Dustex does not disclose personally identifying information other than as described below, and visitors can always refuse to supply such information, with the caveat that it may prevent them from engaging in certain website-related activities.

### **Aggregated Statistics**

Dustex may collect statistics about the behaviour of visitors to its websites and may display this information publicly or provide it to others. However, Dustex does not disclose personally identifying information other than as described below.

### **Protection of Certain Personally Identifying Information**

Dustex discloses potential and actual personally identifying information only to those of its employees, contractors and affiliated organisations that (i) need that information in order to process it on Dustex's behalf or to provide services available on Dustex's websites and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organisations may be located outside your home country; by using Dustex' websites, you consent to the transfer of such information to them. Dustex will not rent or sell actual or potential personally identifying information to anyone. Other than to its employees, contractors and affiliated organisations, such information would be disclosed only in response to a subpoena, court

order or other governmental request, or when the company believes in good faith that disclosure is reasonably necessary to protect the property or rights of Dustex, third parties or the public at large. If you are a registered user of a Dustex website and have supplied your email address, Dustex may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Dustex and our products. If you send us a request (for example via email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. Dustex takes all measures reasonably necessary to protect against the unauthorised access, use, alteration or destruction of actual and potential personally identifying information.

### **Cookies**

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Dustex uses cookies to help Dustex identify and track visitors, their usage of the website and their website access preferences. Dustex visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using the company's websites, although certain features of the websites may not function properly without the aid of cookies.

### **Business Transfers**

If Dustex, or substantially all of its assets, were acquired, or in the unlikely event that Dustex goes out of business or enters bankruptcy, user information would be one of the assets that is transferred to or acquired by a third party. You acknowledge that such transfers may occur, and that any acquirer of Dustex may continue to use your personal information as set forth in this policy.

### **Advertisements**

Ads appearing on any of our websites may be delivered to users by advertising partners, who may set cookies. These cookies allow the ad server to recognise your computer each time they send you an online advertisement to compile information about you or others who use your computer. This information allows ad networks to, among other things, deliver targeted advertisements that they believe will be of most interest to you. This Privacy Policy covers the use of cookies by Dustex and does not cover the use of cookies by any advertisers.

### **Privacy Policy Changes**

Although most changes are likely to be minor, Dustex may change its Privacy Policy from time to time, and in the company's sole discretion. Dustex encourages visitors to frequently check this page for any changes to its Privacy Policy. If you have a dustex.com.au account you might also receive an alert informing you of these changes. Your continued use of this site after any change in this Privacy Policy will constitute your acceptance of such change.
